Description: Investment Risk (Equity Risk Reporting). There are various models present to evaluate equity risk under a particular portfolio.

Currently, the system is using Aegis Model to calculate equity risk with the help of Sybase database. The Aegis model runs for a particular date and job which is the list of all mandates for which risk need to be evaluated.

Once portfolio data is fed into Aegis or Barraone, reports are generated, and risk data is stored in the database. After risk data generated is stored in database, processing of data happens, and final risk report is generated and that is sent to portfolio managers. The report is sent on a daily, monthly, and quarterly basis for Risk Summary Reports, Stress Test Report and Executive Reporting to Portfolio Manager.
